



Executive Summary

This report covers data for the Fourth Quarter 2007.

The main findings of this quarter are as follow:

- 1. Number of licenses: The number of building licenses issued in the Fourth Quarter 2007 totaled 1,062 and were distributed as follows:
 - 640 licenses for new buildings
 - 197 licenses for new additions to licensed existing buildings
 - 42 licenses for new additions and existing parts
 - 173 licenses for existing buildings
 - 10 licenses for existing extensions

Licensed areas: The total areas of licensed buildings (residential & non residential) .2 amounted to 399.6 thousand m² distributed as follows:

- 347.1 thousand m² for new buildings areas, of which 304.1 thousand m² are residential and 43.0 thousand m² non-residential.
- 52.5 thousand m² for existing buildings areas, of which 48.7 thousand m² are residential and 3.8 thousand m² non-residential.
- 3. Licensed boundary walls: 29 licenses issued for walls with total length of 2.2 thousand meters.
 - 4. Number and area of dwellings licensed:
 - New dwellings: 2,612 units with a total area of 286.3 thousand m².
 - Existing dwellings: 275 units with a total area of 45.0 thousand m².

There was an obvious decline in the total number of issued building licenses when the Fourth Quarter of 2007 was compared with the fourth quarter for the period 2004-2005; the decline % when compared with 51.7, and 4% when compared with the Fourth Quarter of 20018.7was; an increase of 29.4% was recorded when compared with the 5the Fourth Quarter of 200 .6Fourth Quarter of 200

The results showed that in the Fourth Quarter of 2007 the number of new dwellings increased by 18.9% compared with the same quarter in 2004. On the other hand, the number of existing dwellings decreased by 33.9% compared with the same quarter in 2004. There was a 9.3% decrease in the number of new dwellings and 76.4% decrease in the number of existing dwellings when the Fourth Quarter of 2007 was compared with the same quarter in 2005. The increase for new dwellings was significant: an increase of 157.3% for the Fourth Quarter of 2007 when compared with the Fourth Quarter of 2006, whereas the number of existing dwellings decreased by 37.7% when compared with Fourth Quarter of 2006.

1. Introduction:

Construction is considered an important economic activity, particularly in countries undergoing economic development. This activity plays a vital role in the Palestinian economy and is significantly interrelated to other economic activities. The Palestinian Central Bureau of Statistics (PCBS) is committed to compiling statistical data on all aspects of construction activity in order to measure the main related variables.

Administrative record statistics shed light on the size and type of building licenses issued by official parties. Building license statistics are compiled by most countries. In addition to its own importance, building license statistics constitute the sampling frame for other surveys to be launched concerning identification of the actual constructed buildings against licenses, estimating construction costs and obtaining data on the technical characteristics of these buildings.

2. Objectives:

These statistics provide data on the number of building licenses and licensed areas, and number and area of licensed dwellings and stores considering the following variables:

- Issuing authorities.
- Geographic location.
- Status of the buildings to be licensed (new, existing, new or existing additions, etc.).
- Building ownership (private, governmental, local authorities, cooperative, etc.).
- Utilization of the building (residential, non-residential: industrial, commercial, educational, etc.).
- Major external construction material (stone, concrete, block, etc.).

3. Definitions:

Statistical Unit:

The license issued by any authorized authority. The issuing authorities are the reporting units for this administrative records statistics.

Building Ownership:

- 1. Private.
- 2. Governmental.
- 3. Local Authority.
- 4. Cooperative Society.
- 5. Charitable Society.
- 6. Other, e.g., religious groups, UNRWA, etc.

Status of the building to be licensed:

- 1. New, when the building site is entirely vacant.
- 2. Addition to an already existing licensed building either a vertical or horizontal addition.
- 3. Addition to non-licensed existing building (or part of a building) that needs licensing.
- 4. Existing building.

5. Existing extension.

Building Utilization:

- 1. Residential: The building is considered residential if more than half of its total area is prepared for residential purposes. The building could consist of:
 - Complete dwellings.
 - Rooms added to the dwellings.
 - Extension of other facilities, e.g., kitchen, bathroom, cesspool, garage.
- 2. Non-Residential: industrial, commercial, educational, etc.
- 3. The boundary wall: in cases when the boundary wall undergoes separate licensing. If the building license includes the wall, then it is not included here.

3.5 Dwelling:

The housing unit of a single household.

3.6 Remaining West Bank:

The West Bank, excluding those parts of Jerusalem which were annexed after the 1967 occupation by Israel.



The results showed an obvious drop for building license indicators during the Fourth Quarter 2007 compared with the Fourth Quarter for the period 2004-2005, despite some vacillation in some indicators compared with the same period or pervious quarters for the same years.

There was an obvious decline in the total number of issued building licenses when the Fourth Quarter of 2007 was compared with the Fourth Quarter for the years 2004, 2005; the decline was 18.7 % when compared with the Fourth Quarter 2004, 51.7 % when compared with the Fourth Quarter 2005; an increase of 29.4 % was recorded when compared with the Fourth Quarter 2006.



5. Data Quality

5.1 Accuracy of the Data

5.1.1 Statistical Errors

The survey was implemented on the basis of a comprehensive census for all studied statistical units (licenses); therefore this survey was free of statistical (sampling) errors.

5.1.2 Non-Statistical Errors

Non-statistical errors are probable in all stages of the project, during data collection or processing. In this survey it is mostly referred to data entry errors. To avoid errors and reduce their effects, great efforts were made to train data entry staff. They were trained on the entry program that was examined before starting the data entry process, and preparing data entry program before data collection for checking readiness of the program for data entry. A set of validation rules was applied to the program for checking consistency of data. Periodic data files were received by project management for checking accuracy and consistency, and notes of correction were provided for data entry management for correction.

5.2 Comparison of the Data

Comparison exercises were done with previous years' surveys of Building Licenses for the same quarter, and the results reveal consistency with previous survey data.

5.3 Technical Notes

There are important technical notes which should be taken into consideration when reviewing this report, which are as follows:

- Tables exclude building licenses for those parts of Jerusalem which were annexed illegally by Israel in 1967, while they include licenses for some villages of Jerusalem Governorate.
- It may be noticed that the details of the value of some indicators may not add up to its total, due to rounding calculations.
