The Main Results

1. Performance of Industrial Enterprises in the Fourth Quarter 2012

1-1 Overall performance

According to the owners/ managers of industrial enterprises, 13.1% indicate that the overall performance of their enterprises had improved during the Fourth quarter 2012 compared with the Third quarter 2012 (11.4% in the West Bank and 23.2% in Gaza Strip).

1-2 Financial conditions

11.1% of owners/ managers of industrial enterprises believe that the financial situation improved during the Fourth quarter 2012 compared with the Third quarter 2012 (9.1% in the West Bank and 23.2% in Gaza Strip).

1-3 Borrowing and financing

Survey results show weak borrowing by active industrial enterprises from banks operating in Palestine during the Fourth quarter 2012: 99.2% of owners of industrial enterprises stated that they refrained from borrowing from banks, while 0.8% of them had applied for a bank loan on one occasion and there is no enterprises borrowed on more than one occasion.

2. Challenges

2-1 Changes in the level of sales

46.4% of owners/ managers of active industrial enterprises in Palestine believed that the main reason for the decline in the level of sales was due to the decrease in consumer purchasing power in the fourth quarter 2012 (51.1% in the West Bank and 27.3% in Gaza Strip). Also, 21.8% stated that seasonally accounted for the decline in sales (17.0% in the West Bank and 40.9% in Gaza Strip).

2-2 Obstacles to exports

The owners/ managers of active industrial enterprises in the West Bank during the fourth quarter 2012 indicated a number of difficulties that hinder their ability to export goods. 77.3% of owners/ managers of export enterprises in the West Bank indicated that Closing entries had the greatest negative impact on export activities, while 61.3% believed that Costumer payment guarantee was an additional obstacle.

2-3 Local and external competition

In Palestine, 96.2% of owners/ managers of active industrial enterprises indicated that the main product manufactured by their enterprises faced competition of some kind (95.6% in the West Bank and 100% in Gaza Strip).

According to 52.0% of owners/ managers of active industrial enterprises, their main item of production faced local competition, while 10.2% of owners cited foreign competition. In addition, 37.8% of owners/ managers of industrial enterprises stated that their main product faced both local and foreign competition.

3. Expectations for the First Quarter 2013

In regard to the expectations of owners/ managers of active industrial enterprises for the first quarter 2013, 18.6% expect an improvement in their situation in general (16.7% in the West Bank and 30.4% in Gaza Strip), meanwhile 19.1% expect an increase in production level (17.3% in the West Bank and 30.4% in Gaza Strip), While 20.1% of the owners/ managers of industrial enterprises in Palestine expect an increase in sales level in the first quarter 2013 (18.4% in the West Bank and 30.4% in Gaza Strip).

4. Level of Satisfaction with Services Provided

There were variations in the level of satisfaction of owners/ managers of industrial enterprises regarding the services provided by private and governmental enterprises during the fourth quarter 2012 according to the type of service provided. The results were as follows:

4.1 Infrastructure and facilities

67.8% of owners/ managers of industrial enterprises in Palestine were satisfied with services related to the Electricity supply services (78.4% in the West Bank and 3.6% in Gaza Strip). Around 78.6% of owners/ managers of industrial enterprises in Palestine indicated satisfaction with water supply (80.7% in the West Bank and 66.1% in Gaza Strip).

4.2 The judicial system and conflict resolution

The results showed that 86.2% of owners/ managers of industrial enterprises in Palestine are satisfied with the fairness of the police on issues related to their enterprises (90.1% in the West Bank and 62.5% in Gaza Strip), while 70.1% of owners/managers were satisfied with the effectiveness of the Palestinian courts (73.1% in the West Bank and 51.8% in Gaza Strip).

4.3 Facilities

In relation to facilities provided by government institutions to obtain required permits and licenses, 56.5% of owners/ managers of industrial enterprises in Palestine were satisfied with the facilities provided (60.8% in the West Bank and 30.4% in Gaza Strip). In addition, 19.1% of owners/managers were satisfied with the information provided to enterprises in Palestine(19.9% in the West Bank and 14.3% in Gaza Strip). Regarding the promotion of policies to assist the development of institutions, 18.8% of owners/ managers of industrial enterprises in Palestine were satisfied (19.6% in the West Bank and 14.3% in Gaza Strip).

5. Obstacles to the expansion of production of industrial enterprises

The owners/ managers of active industrial enterprises during the fourth quarter 2012 indicated a number of obstacles that hinder the expansion of production. About 97.0% of owners/ managers of exporting enterprises in Palestine cited the difficult political situation as having the greatest negative impact on the expansion of production (96.5% in the West Bank and 100% in Gaza Strip), while 92.4% believed that the Low level of income per capita in Palestine is an additional obstacle (93.0% in the West Bank and 89.3% in Gaza Strip).

6. Difficulties finding qualified employees

23.2% of owners/ managers of active industrial enterprises in Palestine revealed that they have difficulty finding suitable trained employees for the company in the fourth quarter 2012 (25.2% in the West Bank and 10.7% in Gaza Strip). Also, 2.3% of owners/ managers of active industrial enterprises in Palestine revealed that they have difficulty finding employees qualified in the academic specialization appropriate to the nature of their company (2.6% in the West Bank and it is not considered as difficulties in Gaza Strip).
