## Sharp rise in the Prices of Local and Imported products lead the Wholesale Price<sup>1</sup> Index (WPI) to Increase During Quarter one 2022

The overall **Wholesale Price Index** in Palestine during Quarter one 2022 **recorded a sharp increase by 3.86%** compared with quarter four 2021 (5.77% for local products, and by 3.20% for imported products).

The changes in WPI for Quarter one 2022 were traced back to changes in prices of the following Division and Category compared with previous quarter:

Wholesale of fruits and vegetables	39.13%
Wholesale of agricultural residues and waste for use as animal feed	14.54%
Wholesale of metals and metal ores	12.20%

Wholesale of dairy products and eggs	5.76%
Wholesale trade in drinks	5.34%
Wholesale of construction materials, hardware, plumbing and heating equipment and supplies	5.31%
Wholesale of live animals	4.40%
Wholesale of liquid fuels	3.34%
Wholesale of gaseous fuels	3.25%
Wholesale of animal and vegetable oils and fats	3.05%
Wholesale and retail trade and repair of motor vehicles and motorcycles	2.68%
Sale of motor vehicle parts and accessories	5.43%
Sale of motor vehicles	3.79%

## Notice for Users:

- The base year of Wholesale Price Index has been updated to be 2021.
- The methodology of Wholesale Price Index has been updated; weights structure, sampling frame and wholesale outlets, and modified Laspers equation in the index compilation.
- Reliance on the International Standard of Industrial Classification of all Economic Activities "Rev.4" issued by the United Nation Statistical Division (UN), to classify wholesale trade division and category within section G "45-47" wholesale and retail trade; repair of motor vehicles and motorcycles, exclude division 47 for retail trade.
- The WPI for quarter four 2021 was recalculated using the new methodology "2021 weight structure, 2021 base year conversion factor" for quarterly comparison purposes.
