**Wholesale Price Index during 2025 and the
fourth quarter of 2025**


**Sharp Increase in Wholesale Price¹ Index
by 9.12% during 2025**

The overall **Wholesale Price Index** in Palestine during 2025 **recorded a sharp increase by 9.12%** compared with 2024 (25.03% for local consumed products and by 1.90% for imported products).

The changes in WPI for 2025 were traced back to changes in prices of the following Division compared with previous year:

Division during 2025	Percent Changes
Wholesale trade, except of motor vehicles and motorcycles	+10.30%
Wholesale and retail trade and repair of motor vehicles and motorcycles	-2.42%

The wholesale price index for the fourth quarter of 2025 declined following the announcement of the ceasefire

The overall **Wholesale Price Index** in Palestine during the Fourth Quarter of 2025 **recorded a sharp decrease by 19.20%** compared with the Third Quarter of 2025 (37.18% for local consumed products, and by 7.52% for imported products).

The changes in WPI for the Fourth Quarter of 2025 were traced back to changes in prices of the following Division and Category compared with previous quarter:

Wholesale of gaseous fuels	-74.72%
Wholesale of live animals	-52.80%
Wholesale of fish, meat and their products	-27.84%
Wholesale of dairy products and eggs	-17.32%
Wholesale of textiles	-17.11%
Wholesale of fruits and vegetables	-16.82%
Wholesale of liquid fuels	-16.30%
Wholesale trade in drinks	-15.18%
Wholesale of agricultural residues and waste for use as animal feed	-9.19%
Wholesale of metallic and non-metallic waste and other materials for recycling	-8.63%
Wholesale of construction materials, hardware, plumbing and heating equipment	-2.58%
Wholesale of solid fuels	+38.38%
Wholesale of animal and vegetable oils and fats	+3.14%
Wholesale and retail trade and repair of motor vehicles and motorcycles	-1.25%
Wholesale or retail of new vehicles	-2.79%

¹The resale (sale without transformation) of new and used goods to retailers, industrial, commercial, institutional or professional users, to other wholesalers, or to those acting as agents or brokers in buying merchandise for, or selling merchandise to such persons or companies. The wholesale price includes VAT and any transport charges



Notice for Users:

- The base year of Wholesale Price Index has been updated to be 2021.
- The methodology of Wholesale Price Index has been updated; weights structure, sampling frame and wholesale outlets, and modified Laspeyres equation in the index compilation.
- Reliance on the International Standard of Industrial Classification of all Economic Activities “Rev.4” issued by the United Nations Statistical Division (UN), to classify wholesale trade division and category within section G “45-47” wholesale and retail trade; repair of motor vehicles and motorcycles, exclude division 47 for retail trade.
- Due to the Israeli attack on Gaza strip in October, 7 2023, the wholesale prices in Gaza strip was estimated according to international recommendation in this field for Fourth quarter 2025.
