Executive Summary

This report includes data about goods and services, taking into account that data on services include imports and exports with Israel that were monitored through VAT vouchers. As in previous reports, this report is based on the registered data in available documents from the official sources in the Palestinian National Authority.

The results indicate that the total value of imports of commodities in 2008 was US\$ 3,466.2 million which reveals an increase by 5.5% compared with 2007, and distributed over 4,164 commodities. On the other hand, the results reveal that petroleum products was the main goods affected the increase in imports.

Regarding imports of services from Israel, the results show that it was US\$ 95.1 million distributed over 64 kinds of services, a decrease by 9.1% compared with 2007.

The data reveals that the total value of exports of commodities in 2008 was US\$ 558.4 million which indicates an increase by 8.9% compared with 2007 and distributed over 1,202 commodities and the main commodity in exports was the building stones. The total value of export of services to Israel in 2008 was US\$ 126.6 million distributed over 61 kind of services, an increase by 3.9% compared with 2007.

The deficit in trade balance amounted to US\$ 2,907.7 million in goods in 2008, and shows an increase by 4.9% compared with 2007. The surplus in balance of trade on services with Israel in 2008 was US\$ 31.5 million.

Regarding trade partners, the results indicate that trade transactions in 2008 occurred with 139 countries. However, Israel represents 80.6% of the whole value of imported commodities, an increase by 14.4% compared with 2007. In addition, 89.4% of the whole value of exported commodities was exported to Israel, an increase by 9.7% over 2007. On the other hand, the total value of direct imports in 2008 was US\$ 655.6 million, which shows a decrease by 21.3% compared with 2007; direct imports from the European Countries represent 33.9% and direct exports to European Countries was 13.7% of the total value of direct exports.

The direct imports of commodities from Arab countries in 2008 was US\$ 75.1 million which shows a decrease by 13.0% compared with 2007. Direct exports to Arab Countries in 2008 was US\$ 45.8 million and increased by 31.8% compared with 2007. The results reveal that US\$ 34.1 million of direct exports in 2008 was exported to Jordan, which represent 74.4% of whole value of direct exports of commodities to Arab Countries.

Regarding direct imports from the USA, the data show that the value of imports was US\$ 33.1 million in 2008, which indicates an increase by 36.4% compared with 2007, while direct exports of commodities to the USA was US\$ 3.6 million in 2008, an increase by 6.0% compared with 2007.

The total value of humanitarian donations was US\$ 102.5 million in 2008 according to the reported documents at the Palestinian Customs.

Chapter One

Introduction

The Foreign Trade Statistics with its three major indicators (imports, exports and trade balance) are considered vital requirements for the National Accounts and Balance of Payments. For these reasons, PCBS puts heavy emphasis on constructing a sound database for Foreign Trade Statistics in Palestine, and publishes a yearly report on the goods and services flowing to and from Palestine.

In the preparation of this report, PCBS committed itself to the recommendations of international statistical concepts adopted within the field of international trade statistics in order to provide data to all users from international institutions and civil society institutions, researchers and scholars, and to provide detailed level data that will be useful in comparisons with all trading partners.

1.1 Aims of the report

The report aims to obtain data on:

- Imported and exported commodities distributed according to the country of origin and destination.
- The countries that Palestine deals with commercially.
- Flow of goods according to the economic purposes.
- Flow of goods according to the means of entry and exit.
- Flow of goods according to the entry passages, borders.
- Flow of services according to the kind of service.

The mentioned data enable the achievement of the following:

- Determining the general net trade balance with other countries.
- Determining the per capita imports and exports.

Obtaining these indicators will realize the following:

- Providing data needed for preparing national accounts, balance of payments, and computing price index for imports and exports.
- Providing data needed for research and economic analysis.
- Providing data for decision-makers and planners.

1.2 Report Structure

This report has been divided into the following chapters:

Chapter One: Includes the introduction and aims of foreign trade statistics, and the report structure.

Chapter Two: Deals with basic concepts and definitions, measurement units and abbreviations included in the report.

Chapter Three: Presents the main results of the report in a short description for main indicators.

Chapter Four: Deals with the methodology of the project in respect to data collection methodology and coverage. It also deals with fieldwork activities for data collection, the methods of data processing and tabulation.

Chapter Five: Deals with data quality of the report, in addition to statistical and non statistical errors.

Tables: The report includes 14 tables on the main indicators of Palestinian trade on goods and services.

Chapter Two

Concepts and Definitions

The Statistical Unit:

In Foreign Trade data the statistical unit is considered by most countries to be the customs declaration, that is, the customs statement issued from the general customs department of countries with all of its enclosures, such as: the certificate of origin, the invoice, the packing list, the health certificate for medicines, food stuff, and meat, the agriculture certificate and the release certificate, etc. However, in Palestine, and as a result of the special situation mainly the lack of control over crossings, the clearance voucher of the value added taxation and the Israeli customs statement and other complementary data are considered the statistical unit in the Foreign Trade report.

The Clearance Voucher for the Value Added Tax:

This is a unified invoice for both Israeli and Palestinian parties. On it appears: the name of the licensed entity from both parties, the taxation number; the exchanged material with its type and value, the invoice number and the value added taxation. This shows the movement of trade exchange between the Palestinian territory and Israel only.

Custom Declaration:

This is an Israeli document containing all the data related to Palestinian direct imports from other countries through the Israeli entries and ports and, additionally, Damyah Bridge, Rafah and Allenby Bridge. A photocopy of the statement which represents direct imports to the Palestinian National Authority territories arrives to the Ministry of Finance but without enclosures since the Palestinian customs statement is partially applied in order to control the data of passengers entry from Jordan and Egypt only.

The Certificate of Origin:

This is a document of the Chambers of Commerce in the governorates and certified by the Ministry of National Economy and reflects data on exports of national origin and re-exported goods to Jordan and the Arab states and other countries of the world except Israel, in addition to the certificate of origin for the European Partnership issued by the Directorate General of Customs and reflecting Palestinian exports of national origin to the countries of Europe

Imports:

Whole commodities (goods) that entered the country by air, land and sea that are used in consumption, convertibility through the manufacturing sector, and re-exportation.

Exports:

Whole commodities (goods) that are exported outside the country, conditioned with ownership transcription to another economy, or to free customs regions.

Trade Balance:

The difference between Exports and Imports

C.I.F – Cost, Insurance and Freight:

Cost of the imported goods plus the cost for loading and transportation within the exporting country plus the cost of the transport from the border or port of the exporting country to the border or port of the importing country.

FOB – Free on Board:

Total cost of exported goods plus the cost for transportation within the country of dispatch, including possible loading cost in the port of dispatch.

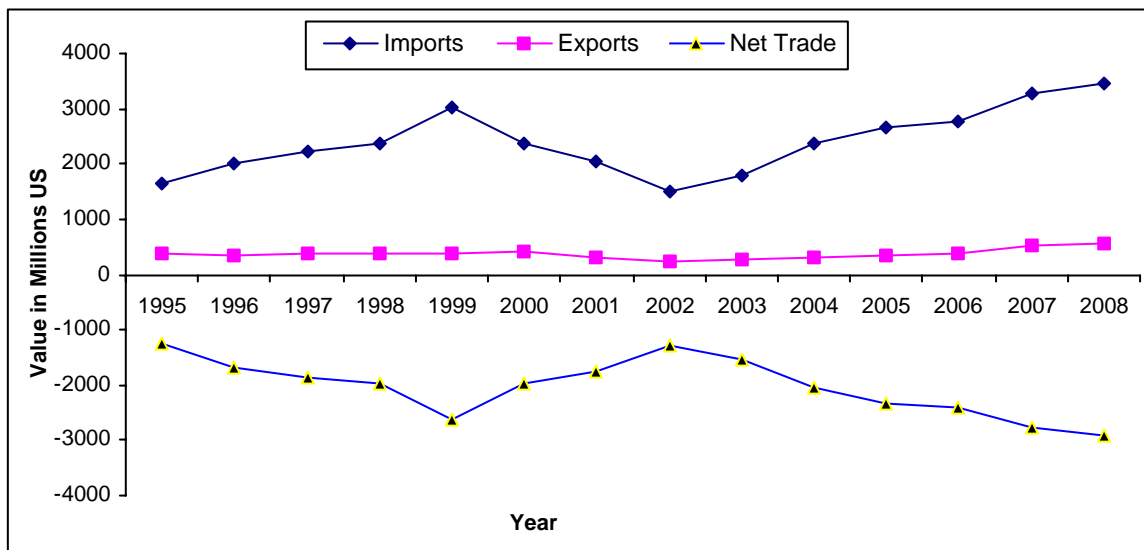
Main Results

Foreign trade transactions are very important in economic activities due to their role in Gross Domestic Product (GDP) and the creation of job opportunities. In addition, this sector plays a crucial role in regional and international communication. This chapter presents data on foreign trade activities and summarizes the main results for the year 2008.

3.1 Imports and Exports of Goods by Year

The results indicate that the total value of imports of goods in 2008 was US\$ 3,466.2 million which reveals an increase of 5.5% compared with 2007. On the other hand the total value of exports of goods was 558.4 with an increase of 8.9% compared with 2007. The deficit in net trade balance increased in 2008 and reached US\$ 2,907.7, while deficit in 2007 was US\$ 2,771.1 The deficit of the net trade balance was due to the increase in imports compared with exports.

Figure 1: Distribution of Imports, Exports in Goods and Net Trade Balance in the Palestinian Territory, 1995 - 2008

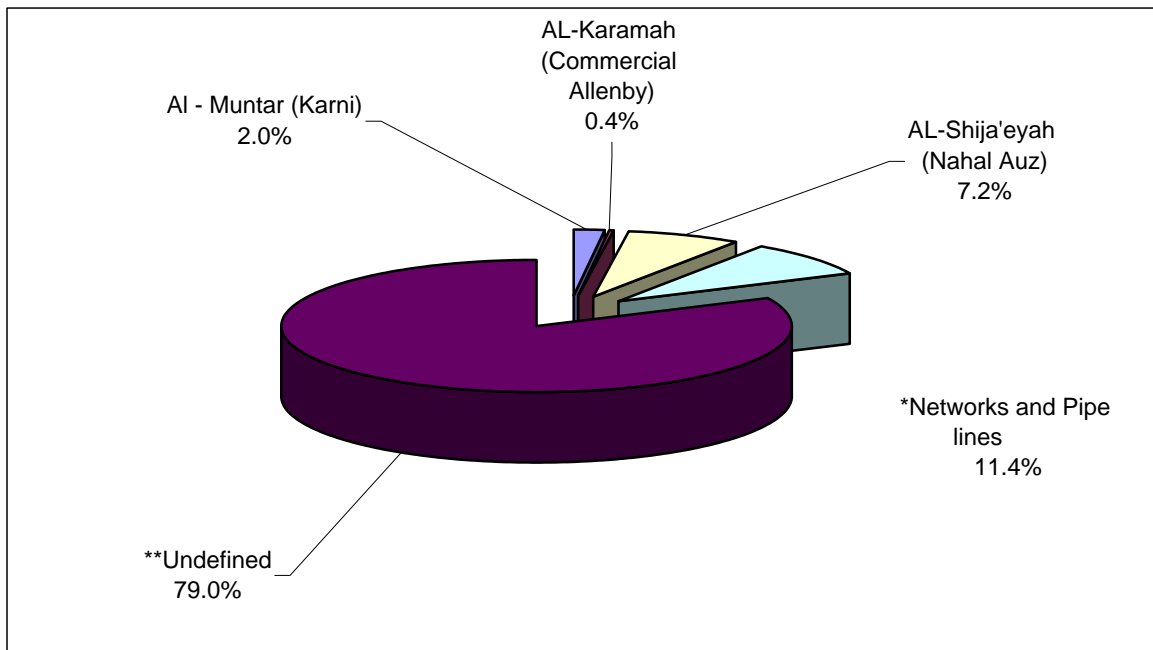


3.2 Imports of Goods by Entry Passage in 2008

The results indicate that the major amount of imports in 2008 entered the West Bank via “undefined” centers which deal with goods from Israel to the West Bank. The imports via the “undefined” center was 79.0% of total imports with an increase of 14.1% compared with 2007. Imports through Al-Muntar passage to Gaza Strip was 2.0%, a decrease by 75.8% compared with 2007.

Imports through networks and pipelines was increased by 29.3% compared with 2007.

Figure 2: Distribution of Imports in Goods in the Palestinian Territory by Entry Passage in 2008



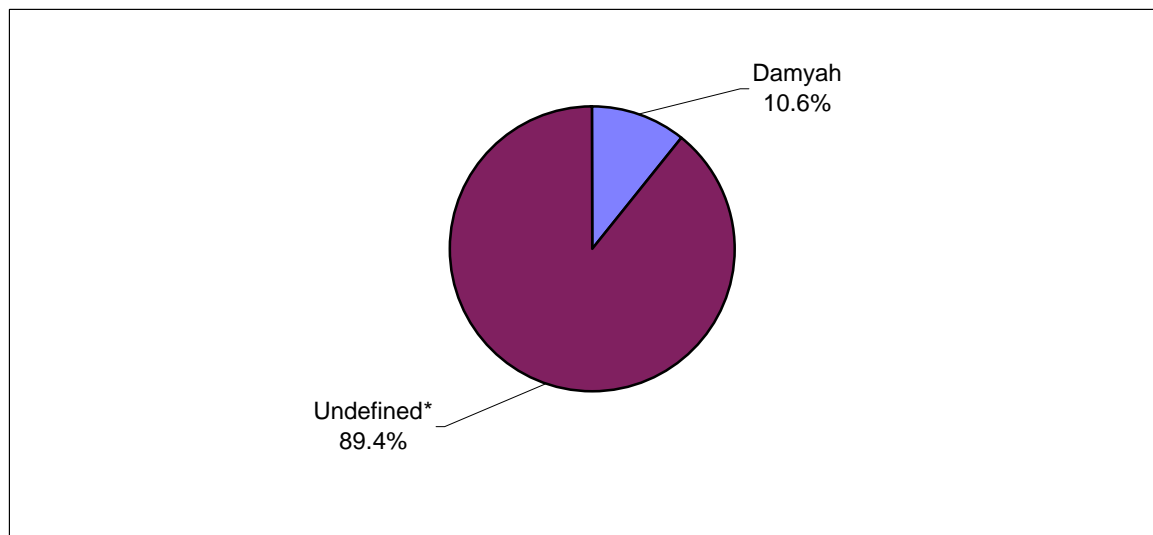

3.3 Exports of Goods by Exit Passage in 2008

The results indicate an increase in the exports of goods abroad in 2008 through Damyah passage by 38.4%, an amount representing 10.6% of total exports. The exports from the West Bank through “undefined” passage represents 89.4% of total exports of goods, an increase by 11.5% compared with 2007.

Chapter Four

Methodology

The main target in the preparation of Palestinian external trade statistics is to monitor actual flows of goods and services during the period of time reference. Due to the political and economic conditions of the Palestinian territory, PCBS has used VAT vouchers from the Ministry of Finance as a major source of data on trade exchange with Israel, in addition to other official sources related to external trade with the rest of the world, as mentioned in the first part of this report.

4.1 Field Operations

As mentioned, PCBS adopted several data sources for calculating trade statistics such as:

Value Added Taxation Vouchers:

By using special forms; a specialized technical team from the PCBS dealt directly with vouchers at the Ministry of Finance where goods and services with Israel are collected, and transferred them to the headquarters of PCBS for processing.

Customs Data:

PCBS has adopted the General Administration of Customs and Asycuda project for covering trade with countries abroad (direct imports) via Israeli ports and airports. The data is transferred to the PCBS in electronic format and broken down by Israeli customs tariffs in addition to the value, quality and country of origin. The files distributed then by sections, chapters and main groups of H.S in addition to H.S 6 digit tables.

Besides the VAT vouchers and the Customs declarations data, which are the main sources, there are other types of data sources for the Foreign Trade Statistics in Palestine as follows:

- The Ministry of National Economy
- The Palestinian Water Authority
- The General Petroleum Corporation
- The Ministry of Agriculture
- The Ministry of Telecommunications and Information Technology

4.2 Data Processing

Office operations for foreign trade data can be summarised in three phases as follows:

- Data documentation
- Coding and data checking using H.S and correspondence tables for International classifications
- Tabulation phase using Access and Excel software for preparing goods and services tables

Data Quality

5.1 Accuracy of the Data

Statistical Errors

PCBS collects foreign trade data in accordance with international standards, where access to data is based on the official administrative records of various data sources, and consequently the data of this program are not affected by statistical errors.

Non-Statistical Errors

Errors that can occur due to the statistical nature of the work at the Directorate of VAT, such as clearing bills that focus on the fiscal side only, resulting in shortages in other aspects such as the measurement of the quantities (weight and number), and non-billing breakdown by commodity. This lack of information has been overcome through the following :

1. Audit traders and professionals licensed by the Directorate of VAT.
2. Accountants audit - through auditing offices - which provide invoices of persons engaged with the Directorate of VAT, in collaboration with the Directorate.
3. District office audit for VAT for error correction, if any action, to improve performance.
4. Audit of the Ministry of National Economy to correct any errors in the data in terms of the certificates of origin breakdown of commodities and price adjustment if illogical unit prices found.
5. Providing data entry program with three checks to address errors resulting from input mistakes, and updated on an annual basis, checking rules as needed.

5.2 Comparison of the Data

Comparison of data of this report with the published data for other sources, noting:

1. Mismatches of data between different mechanisms for the collection and processing of data due to the different methodology, coverage and comprehensiveness of each data source to another.
2. Published figures on imports and exports by partner countries might be different due to the methodology or the applied trade system.

5.3 Technical Comments

Statistical figures of Palestinian external trade issued by the PCBS in this bulletin is to monitor the movement of actual commodity flows entering the Palestinian territories, taking into account the following observations:

1. The value of imports and exports published in this report do not include VAT.
2. Data were calculated on the basis of oil derivatives, the average sale prices of power distribution for these derivatives, and the monthly level of the General Petroleum Corporation, after deducting a percentage for the profit margin and VAT.
3. The statistical figure of this report for commodity imports and exports is the figure approved for the preparation of the trade accounts, the rate of contribution of imports and exports of GDP. The number is actual and not based on estimates and official documents.
4. Imports and exports do not include smuggling of goods across crossings to the Palestinian territories.

5. Imports and exports of goods do not include any non-appropriated documents in the trade exchange with Israel.
6. Imports and exports with Israel contain indirect imports and exports with the countries of the world, because of a country of origin or destination in the bill, and that means:
 - Palestinian imports from Israel are not necessarily originated in Israel, but Israel is the country of shipment of the goods.
 - Palestinian exports to Israel include Palestinian exports to the countries of the world through Israel.
7. The data contained in this report does not include that part of Jerusalem governorate which was annexed by Israel in 1967.
8. There are some minor differences in the totals of the values of the same variable between different tables, that resulted from the convergence of standard treatment processes on the computer.
9. The value of imports was calculated on the basis of (C.I.F) and the value of exports has been calculated on the basis of (F.O.B).
10. Imports and exports represent service trade with Israel service only.
11. Figures of 2008 might be changed in the coming report for 2009.
12. Financial data was collected by NIS, US \$ and JD, but it was converted and published in US \$.
